




Figure 1-1 Overview of Type I




Figure 1-3 Overview of Type II




Figure 1-4 Overview of Type III

Note:

- For type II and III camera, only certain models support the memory card installation.
- Hold RESET about 10s when the camera is powering on or rebooting to restore the default settings, including the user name, password, IP address, port No., etc.
- A wireless router with the WPS function is required to enable the WPS function of the camera. Refer to the steps below.

Steps:

- 1) Press the WPS button on the router.
- Press the WPS button (about 2s) on the camera within 120s you enable the WPS of the router to join in the wireless network.

Note:

- The WPS button works as a reset button only when you press it when the camera is powering on.
- Press the WPS button on the camera, and then press the WPS button on the router will work as well, and the expire time of WPS connection on the camera is 120s.

2 Installation

Before you start:

- Make sure the device in the package is in good condition and all the assembly parts are included.
- The standard power supply is 12 VDC. Make sure your power supply matches with your camera.
- Make sure all the related equipment is power-off during the installation.
- Check the specification of the products for the installation environment.
- Make sure that the wall is strong enough to withstand four times the weight of the camera and the bracket.

For the camera that supports IR, you are required to pay attention to the following precaution to prevent IR reflection:

Make sure that there is no reflective surface too close to the camera lens. The IR light from the camera may reflect back into the lens causing reflection.

2.1 Camera Mounting

2.1.1 Wi-Fi Antenna Mounting

Only type I and type II support Wi-Fi antenna mounting.

Steps:

 Align the antenna to the interface and clockwise screw up the antenna as shown in the figure below.




Figure 2-1 Mount the Antenna

2. Tighten the locking nut using the supplied wrench.




Figure 2-2 Tighten the Locking Nut

2.1.2 Memory Card Installation

Only certain models of the type II and type III support memory card installation and the steps are similar. Here takes type III as an example to introduce the steps.

Steps:

1. Loosen the screws to remove the memory card slot cover.

- 2. Insert the memory card into the slot.
- 3. Replace the slot cover and fix the screws.




Figure 2-3 Install the Memory Card

2.1.3 Wall/Ceiling Mounting

Type I, II and III camera support wall and ceiling mounting and the steps are similar. Here takes type I as an example to introduce the steps.

Steps:

1. Paste the drill template on the wall or ceiling and drill holes according to the marked holes on the drill template.




Figure 2-4 Drill the Holes

- If you need to route cables through the wall or ceiling, cut a cable hole according to the drill template. Skip this step if you want to route the cables on the surface of the wall or ceiling.
- 3. Route the cables of the camera.
- 4. Install the camera to the wall or ceiling with screws.




Figure 2-5 Install the Camera

5. Adjust the view angle of the camera.

3-axis (pan/tilt/rotation) adjusting allows adjustment for optimum camera rotation and placement.

- 1). Loosen the 3-axis adjusting nut.
- Adjust the panning, tilting and rotation position of the camera. The adjusting range of the panning is from 0° to 360°, range of the tilting is from 0° to 90° and range of the rotation is 0° to 360°.
- 3). Tighten the adjusting nut.




Figure 2-6 View Angle Adjustment

2.2 Installation of Network Cable Waterproof Jacket (Optional)

Purpose:

If the camera is installed outdoor, you can use the waterproof accessory for the network cable after the camera is secured on the installation surface.

Steps:

 Feed the plugless network cable ⑦ through the lock nut ⑥, waterproof rubber gasket ⑤ (the rubber gasket inset ridge

must face the waterproof endcap), and the waterproof endcap 4 in order.

- Crimp an RJ-45 network plug (3) onto the end of the cable, taking care to insert the twisted pairs of wires in correct order.
- Place the O-type gasket (2) onto the end of the camera's network interface socket (1).
- Insert the network plug (3) into the camera's network interface socket (1).
- Insert the waterproof rubber gasket (5) into the waterproof endcap (4), and secure lock nut (6) with the waterproof endcap (4).
- 6) Align the snap on the waterproof endcap ④ with the notch on the camera's network interface socket ①, and then secure the waterproof endcap ④ to the camera's network interface socket ① to finish installation.




Figure 2-8 Waterproof Accessory Installation

3 Setting the Network Camera over the LAN

Note:

- If the camera is used with a Wi-Fi NVR that can work as a wireless network router, the camera can connect to the NVR's Wi-Fi automatically after the camera is powered on. You can activate, add and configure the camera on the NVR. Make sure the NVR's Wi-Fi has been configured in advance. Refer to Quick Start Guide of Network Video Recorder for details.
- You shall acknowledge that the use of the product with Internet access might be under network security risks. For avoidance of any network attacks and information leakage, please strengthen your own protection.
- If the product does not work properly, contact your dealer or the nearest service center for help.

3.1 Wiring

Connect the camera to network according to the following figures.



Figure 3-1 Connecting Directly




Figure 3-2 Connecting via a Switch or a Router

3.2 Activating the Camera

You are required to activate the camera first by setting a strong password for it before you can use the camera.

Activation via Web Browser, Activation via SADP, and Activation via Client Software are all supported. We will take activation via SADP software and Activation via Web Browser as examples to introduce the camera activation.

Note:

Refer to the User Manual of Network Camera for Activation via Client Software.

3.2.1 Activation via Web Browser

Steps:

- 1. Power on the camera. Connect the camera to your computer or the switch/router which your computer connects to.
- Input the IP address into the address bar of the web browser, and press Enter to enter the activation interface.

Notes:

- The default IP address of the camera is 192.168.1.64.
- The computer and the camera should belong to the same subnet.
- For the camera enables the DHCP by default, you need to use the SADP software to search the IP address.

3. Create a password and input the password into the password field.

- 4. Confirm the password.
- 5. Click OK to save the password and enter the live view interface.

3.2.2 Activation via SADP Software

SADP software is used for detecting the online device, activating the camera, and resetting the password.

Get the SADP software from the supplied disk or the official website, and install the SADP according to the prompts.

Follow the steps to activate the camera.

Steps:

- 1. Run the SADP software to search the online devices.
- Check the device status from the device list, and select the inactive device.

Create and input the new password in the password field, and confirm the password.

4. Click Activate to start activation.

You can check whether the activation is completed on the popup window. If activation failed, make sure that the password meets the requirement and try again.

3.3 Modifying the IP Address

Purpose:

To view and configure the camera via LAN (Local Area Network), you need to connect the network camera in the same subnet with your PC.

Use the SADP software or client software to search and change the IP address of the device. We take modifying the IP Address via SADP software as an example to introduce the IP address modification.

For IP address modification via client software, refer to the user manual of client software.

Steps:

- 1. Run the SADP software.
- 2. Select an active device.
- Change the device IP address to the same subnet with your computer by either modifying the IP address manually or checking the checkbox of Enable DHCP.

4 Accessing via Web Browser

System Requirement:

- Operating System: Microsoft Windows XP SP1 and above version
- CPU: 2.0 GHz or higher
- RAM: 1G or higher
- Display: 1024×768 resolution or higher
- Web Browser: Internet Explorer 8.0 and above version, Apple Safari 5.0.2 and above version, Mozilla Firefox 5.0 and above version and Google Chrome 18 and above version

Steps:

- 1. Open the web browser.
- In the browser address bar, input the IP address of the network camera, and press the Enter key to enter the login interface.

Note:

The default IP address is 192.168.1.64. You are recommended to change the IP address to the same subnet with your computer.

3. Input the user name and password.

The admin user should configure the device accounts and user/operator permissions properly. Delete the unnecessary accounts and user/operator permissions.

Note:

The device IP address gets locked if the admin user performs 7 failed password attempts (5 attempts for the user/operator).

4. Click Login.

6. Reopen the web browser after the installation of the plug-in and repeat steps 2 to 4 to login.

For detailed instructions of further configuration, please refer to the User Manual of Network Camera.

5 Operating via Hik-Connect App

Purpose:

Hik-Connect is an application for mobile devices. With the App, you can view live image of the camera, receive alarm notification and so on.

Note:

Hik-Connect service is not supported by certain camera models.

5.1 Enable Hik-Connect Service on Camera

Purpose:

Hik-Connect service should be enabled on your camera before using the service.

You can enable the service through SADP software or web browser.

5.1.1 Enable Hik-Connect Service via SADP Software

Steps:

- 1. Check the checkbox of Enable Hik-Connect on:
 - "Activate the Device" page during camera activation, refer to Chapter 3.2.2.
 - Or "Modify Network Parameters" page during modifying IP address, refer to Chapter 3.3.
- 2. Create a verification code or change the verification code.

- 3. Select Platform Access Mode as Hik-Connect.
- 4. Check the checkbox of Enable.
- Click and read "Terms of Service" and "Privacy Policy" in pop-up window.
- 6. Create a verification code or change the verification code for the camera.

5.2 Hik-Connect Setup

Steps:

- Download and install the Hik-Connect app by searching "Hik-Connect" in App Store or Google Play™.
- 2. Launch the app and register for a Hik-Connect user account.
- 3. Log in Hik-Connect app after registration.

5.3 Adding Camera to Hik-Connect

Before you start:

You need to enable the Hik-Connect service on camera before adding it to your Hik-Connect account. Refer to Chapter 5.1.

Steps:

1. Use a network cable to connect the camera with a router if the camera does not support Wi-Fi.

After the camera connects to the network, please wait one minute before any operation on the camera using Hik-Connect app.

2. In the Hik-Connect app, tap "+" on the upper-right corner and then scan the QR code of the camera to add the camera.

If the QR code is missing or too blur to be recognized, you can also add the camera by tapping the aircon and inputting the camera's serial number.

3. Input the verification code of your camera.

Note:

- The required verification code is the code you create or change when you enabling Hik-Connect service on camera.
- If you forget the verification code, you can check the current verification code on Platform Access configuration page via web browser.
- Follow the prompts to set the network connection and add the camera to your Hik-Connect account.

Note:

For detailed information, refer to the user manual of the Hik-Connect app.

5.4 Initializing the Memory Card

Note:

The memory card is only supported by certain models. See the actual device for details.

Steps:

Check the memory card status by tapping on the Storage Status in the Device Settings interface.

If the memory card status displays as Uninitialized, tap to initialize it. The status will then change to Normal. You can then start recording any event triggered video in the camera such as motion detection.
